Water meters have not been fitted in these quarters and allottees are charged at a flat rate Rs. 9 per month.'

The rates for unmetered quarters are fixed on the basis of actual consumption of water by the allottees. In newly constructed quarters, pending collection of data for fixation of rates, provisional rates are fixed. It has since been checked up that rates as were fixed intially were further revised provisionally in order to prevent accumulation heavy arrears. The rates provisionally fixed for type I quarters in 'K' block, Clive Sq. and Type III quarters in Baba Kharak Singh with effect from 1-5-1980 were Rs. 11 per month and Rs. 16 per month respectively.

I accordingly request that the following may be substituted in place of reply given to part (b) of the said question:-

'Water metres have not been fitted in those quarters. The allottes of 'K' Block, Type I quarters in Clive Square and Type III quarters in Baba Kharag Singh Marg are being charged Rs. 11 and Rs. 16 per month respectively, pending fixation of final rates the basis of actual consumption of water'.

The inconvenience caused is regretted.
