that there is not a single family station where families are allowed to go and stay. During my earlier visit to this area, one plea made by the people was that they should have families with them to avoid various prob. lems which are created locally. 1 would, therefore, ask the Minister whether there is any time-bound programme—the Prime Minister is here— to see that the families go and stay there so that there is more contact between the families of the Army an I the loca people.

SHRI SHIVRAJ V. PATIL: Siry-when the family station is there, certain kinds of facilities are mads available.

MR. CHAIRMAN: The question is, first there is no family station.

SHRI SHIVRAJ V. PATIL: I am coming to that. Housing -xcommoda-tion has to be made available as also the transport system, hospital and school. When school facilities are there generally . . . (Interruptions) if the school facility is not available generally it is not treated as family station. This is so even if all other things are available but the school facilities are not available. In the northeastern region, we have other facilities, but because some school arrangements are not there, they cie not treated as family stations. But we have other facilities available where the family members can go and stay wit'h them. I have given the categories of the accommodation made available to them. Some families can go there and stay with the soldiers. We do share the concern shown by the hon. Members when they say that we should fake steps to see that more houses are constructed for the family members. I have informed the House that we have spent about Rs. 31 crores for co.nstructing housing accommodation. (Interruptions) We would certainly take steps

SHRIMATI MONIKA DAS: Sir,.... (Interruptions),

SHRIMATI MONIKA DAS: 1 would like to know whether there is any proposal under the Government's consideration to set up a commission in order to settle boundary disputes. It so, that are the details in this regard? Sir, I would like to know particularly about my State Karnataka, the Bcl-gaum dispute wii'a Maharashtra and the Kasargod dispute with Kerala. So I would like to know whether the Government. . . (Interruptions) Please, you must hear first; then you can fight. So, has the Government taken any decision to maintain the status quo there? Are they maintaining the status quo or not?

SHRI YOGENDRA MAKWANA: Sir, these disputes can be resolved only with the willing co-operation of the States. And the Government is trying to settle the disputes between the States.

SHRIMATI MONIKA CAS: My second question. If so, what are the details for it? I want the details for that in every States.

SHRI YOGENDRA MAKWANA: Sir, I said that there are different disputes regarding the boundaries in different States. Some hon. Members on the other side was asking about Bihar-Uttar Pradesh also. These are the disputes regarding the demarcation ol boundaries on the ground.

A news report has appeared now and it is not that the Government of India is not aware of it. Is it that with its consent he has issued the statement or is it that in spite of Government of India's dissatisfaction with him that he has

sued that statement? Do they approve | of it or not?

SHRIMATI INDIRA GANDHI; No permission was taken, Sir.

MR. CHAIRMAN: Yes, Mr. Kul-karni.

SHRI PATTIAM RAJAN: Sir, where is the answer? (*Interruption*^)

MR. CHAIRMAN: Yes, Mr. Kul-karni.

SHRI ARVIND GANESH KULKARNI: Sir, may I know from the honourable Home Minister whether he is aware of the fact that a statement was made by the Prime Minister in Kolhapur during the election time that the border dispute beiween Karnataka and Maharashtra would be solved ofter the elections were over? I would like to know also whether it is true... (Interruption).. You just wait, Mrs. Margaret Alva. Sir, I would also like to know whether it is true that the Prime Minister mentioned that the border dispute has a very lew priority. (Interruptions)

SHRIMATI MONIKA DAS: Mr. Kulkarni, there is no dispute between Karnataka and Maharashtra. (Inter-rupUons)

SHRI ARVIND GANESH KULKARNI: Sir, I want to know from the Home Minister which of the Statements of the Prime Minister is true. Secondly, Sir. the initiative to be taken by the Home Minister will never come, even for a hundred years to come. But he is responsible for solving the problem. Then, Sir, as far as the assurance of the Prime Minister is concerned, the Centre has to take the responsibility.

SHRIMATI INDIRA GANDHI: Sir, I am sitting here. It is extraordinary that' questions about my statements are being discussed with another minister.

Sir. I have always maintained that all disputes «hould be settled as soon

as possible and with the greatest satisfaction or, rather, the least dissatisfaction to the people concerned. This is all that I have said either when delegations have come to meet me or in any public or private forum. My stand remains the same. It is unfortunate that we have these disputes, and we should try to settle them. The only thing is that when there are so many major problems and tensions, we should not add to them. This would not lead to a successful solution of such problems either. It is only when thera is...

SHRI ARVIND GANESH KULKARNI: What about the time-limit for it?

SHRIMATI INDIRA GANDHI: There can be no time-limit. In such matters you cannot have any time-limit. We must try to solve them as soon as possible. Now, the honourable Member knows that even on his side... (I?itejTuptions)... in his Party also, there are two different opinions as in every party. (Interruptions)

MR. CHAIRMAN: I cannot call everybody. Yes, Mr. Manubhai Patel.

SHRI MANUBHAI PATEL: Sir, this is really a very sensitive issue and it is not an issue of the (Government only, but it is also a national issue and it should be settled amicably. The only criterion should be the administration and the economic growth of the concerned States so that the local people do not have the feeling that there is imbalance and all that. Now, Sir, I would like to know one thing. There are distant areas in the country like Diu and Daman and Dadra and Nagar Haveli. Now, Diu is in one corner of Saurashtra and it is administered from Goa, Daman is also like that. Then. Dadra and Nagar Haveli are tribal areas. Now it is very difficult. Only last week this House passed an amendment Bill regarding the creation of a Special High Court Bench there. May I know whether this issue will also be settled' at the earliest so that the people will

rural areas and the poverty line of Rs, 75 corresponding to calorie requirement of 2100 in urban area\*.
