Central financial assistance is released to the States in the shape of 'block loans' and 'block grants' without their being tied to any particular sdienie or head of development. The State Governments are free to earmark funds ^or various State sector programmes including housing according to their requirements and priorities. The objectives and guidelines in the Sixth Five Year Plan (1980-85) lay due emphasis on housing for the weaker sections.
