**Industrial Development in Bhavnagar and Amreli Districts in Gujarat**

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) According to the information contained in the District Industries Centre Action Plans, Bhavnagar and Amreli districts have locally available raw materials which could be utilised for setting up industries.

(b) These two districts are already eligible for concessional finance from All India Term Lending Financial Institutions.
