(c) if so, what are the reasons therefor and what steps Government have taken for payment of arrears to Delhi Police pei'sonnel to remove the anomaly?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): (a^i The payment of House Rent Allowance without production of rent receipt has been raised to 25 per cent *U'.e.f.* 1-2-1978, in respect of non-gazetted police personnel of CBI posted in Delhi and the Delhi Police personnel entitled to rent free accommodation. In respect of IB this has been raised *w.e.f.* 23-11-1979.

(b) and (c). According to the Ministry of Finance O.M. dated the 3-9-1974 such of the employees who are entitled to rent free accommodation drawing pay upto Rs. 750 p.m. were entitled to house rent allowance @ 15% plUg compensation @ 10% *Th%*, in lieu of rent free accommodation, only on production of rent receipt of having paid rent exceeding 25%, otherwise the entitlement was restricted to the actual rent paid or the house rent allowance @ 15% as admissible to other employees.

The Delhi Police/Delhi Administration have reported that so far none of the eligible police personnel had produced the rent receipt in support of their claim. As such the question of denial of payment of house rent allowance at increased rates for 51 months does not arise.
