During January 1981, out of a total loading of 20 wagons to destinations on N.F. Railway, only 8 were loaded by M/s. Crown Timber and. Foods Pvt. Ltd., and M/s. Yamuna Packing Industries (P) Ltd., while the other 12 wagons were loaded by other parties.

(c) After receipt of representation from the Indian Tea-Chest Battens Manufacture^ Association, Yamuna Nagar, instructions were issued to the Northern Railway that the party should not be given any further ad-hoc assistance for clearance of their traffic unless the request is routed through and recommended by the Railway forwarding the request and indent numbers are given. This will ensure that only genuine demands after due verification are entertained.
