assistance from the (b) The loan IBRD has an average repayment period of about 20 years with 3 to 5 years grace period. The lending rate is reviewed by the Bank from time to time and at present the rate of interest is 9.60 per cent per annum.

The credit from IDA are repayable over a 50 year period inclusive of a moratorium of 10 years. The credits are interest free and carry only a service charge of 0.75 per cent per annum.

The principal of Bank loans and IDA credits is generally repayable in six monthly instalments.

The IFC loans are repayable over a 10-12 years period with a grace period of 4 years.

(c) Estimates of receipts for 1981-82 will be known after the Budget Estimates for that year are finalised.
