

**Increase in naxal activities**

†\*386. SHRI LALIT KISHORE CHATURVEDI: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that naxalite activities have increased in forests areas of naxal affected States Jharkhand, Chhattisgarh, Orissa, Andhra Pradesh, Bihar and Madhya Pradesh since the year 2003;

(b) whether coordinated and integrated efforts to check the said activities in naxal affected States could not be made due to the lenient attitude of Central Government and some State Governments towards them; and

(c) whether any intense campaign to get rid of the said problem is under consideration of Government; if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SHRIPRAKASH JAISWAL): (a) As per available information, forests and the tribal inhabited areas in the naxal affected States have been the focus of naxalite activity. These areas have not seen any increase in naxalite activities since 2003.

(b) and (c) The naxal affected States have been pursuing a multi-pronged approach to address the naxalite menace on political, security and development fronts in a holistic and coordinated manner. The Central Government continues to provide all possible help to these States and facilitate coordination between them to effectively deal with the challenge posed by naxalism.

**Threat to Kashmiri Pandits by Terrorists in valley**

declare performance of 'Mahashradh' in Jammu instead of valley in view of threats from terrorists; and

(b) if so, whether Government will ensure that they are able to return to valley at least for such acts?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SHRIPRAKASH JAISWAL): (a) and (b) The Government is committed to provide security cover to all citizens, including Kashmiri Pandits. This year the State Government had assured security cover to Panun Kashmir, an organization of Kashmiri Pandits in order to enable them to perform 'Mahashradh' in the Valley but despite the assurance given by the Government, they chose to perform 'Mahashradh' in Jammu (Akhnoor) on August 6, 2006. Many religious functions such as Kheer Bhawani Mela and Amarnathji Yatra held in the Valley every year in which Kashmiri Pandits take part in large numbers Government takes all measures for their security and safety.

#### **Compensation to farmers for laying mines**

(a) whether full and final compensation have since been paid to all the eligible farmers whose lands were used for laying mines etc., by the army on the Indo-Pak border in J&K especially in Ranbir Singh Pura Sector;

(b) whether any claims are still pending; and

(c) if so, the details thereof?

THE MINISTER OF DEFENCE (SHRI PRANAB MUKHERJEE): (a) to (c) A sum of Rs. 72,59,56,394/- has been placed at the disposal of the State Government of Jammu & Kashmir (concerned Deputy Commissioners) for payment to the affected farmers for occupation of lands in the border areas in the districts of Jammu, Kathua, Poonch, Rajouri and Udhampur, in connection with Operation Parakram. Out of the above amount, Rs. 23,01,10,550/- is for occupation of land in Tehsil Ranbir Singh Pura. No claim for compensation in this regard is pending in the Ministry.
