#### Implications on India's Foreign Trade by Policies adopted by E.E.C. countries and the United States

799. SHRI K. CHATHUNNI MASTER; Will the Minister of COMMERCE be pleased to state:

- (a) what are the implications and impediments created on the foreign trade by the protectionist policy adopted by the E.E.C. countries and the U.S.A.; and
- (b) what is the position of our export and import in the years 1975 to 1980, year-wise to these countries?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHED ALAM KHAN): (a) The protectionist policies adopted by the E.E.C. countries and the USA have been affecting the exports of India adversely. The major items affected are certain steel and engineering products, footwear, textiles and clothing in all of which India has good export potential. The USA have imposed countervailing duties on certain types of leather footwear, industrial fasteners and certain iron castings imported from India on the ground that these products are being subsidised by India. They have also initiated anti-dumping investigations on the same iron castings. Imports of industrial fasteners into USA face in addition a substantial temporary duty imposed about two years ago for safeguarding their domestic industry from injury. The EEC have also been adopting a restrictive policy on the import of textile items from India. There have been hold ups of consignments and expansion of lists of restraints together with requests for placing more and more categories under restraint The EEC have also

placed imports of shoes under surveillance. Though surveillance has not affected exports directly so far, the threat of restraint is an inhibiting factor on the growth of our export industries. These protectionist mea-

sures have created an uncertain trading environment.

### Import of Sugar from M|s. ED and F Man (Sugar) Limited, London

800. SHRI BHOLA PRASAD: Will the Minister of COMMERCE be pleased to state;

- (a) whether under the terms of contract of the State Trading Corporation with M/s. ED and F Man (Sugar) Limited, London, the firm had the right to make a ten per cent change  $o_n$  the quantity while supplying ahd receiving back the sugar; and
  - (b) if so, what is its implications?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI KHURSHED ALAM KHAN): (a) Yes, Sir.

(b) The plus|minus variation clause at seller's option for C" and F contracts and at buyer's option for FOB contracts, is a normal feature in the international sugar Import[Export contracts. In this case, in the import contract, M|s. ED¹ and F Man (Sugar) Lfcmited, London, exercised the minus 10 per cent option and supplied 180,245 MTs. of sugar against the contract for 200,000 MTs. As the edrpoEft contract js jyet to be fully MAL

implemented, it is not possible to indicate at this stage the exact quantity the buyer will accept in exercise of his option under this contract.
