Disease affecting coconut trees

- '(a) whether Government's attention has been drawn to the fact spreading of disease to coconut and orange plantation in Kerala;
- (b) whether the Government of Kerala have sought any financial assistance from the Central Government recently to fight the dieseases; and
- (c) if so, the quantum of Central assistance given or proposed to be given to the State Government for the purpose?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND RURAL RECONSTRUCTION (SHRT R. V. SWAMINATHAN): (a) Yes, Sir, so far <?s the coconut root wilt and leaf roo' disease is concerned.

- (b) Yes, Sir, so far as the coconut disease is concerned.
- (c) A Centrally Sponsored Scheme for Rejuvenation of diseased and unproductive coconut plantation in Kerala State has been under implementation since 1977-78. Under this scheme supply of hybrid coconut seedlings and fertilizers for the new plantings are offered to the growers at 50 per cent subsidised cost to under plant and replant Root Wilt affected coconut gardens. During the years 1977-78 and 1978-79, Central assistance (100 per cent) to the tune of Rs. 38.44 lakhs to cover a total of 19,800 hectares was sanctioned to the State. From 1979-80 the expenditure for the scheme is being shared on an equal basis between the Government of India and the State Government. During 1979-80 Government of India's Share of expenditure was Rs. 5.190 lakhs to cover a total oi 11000 hectares. During the Sixth Plan period 1980-81 to 1984-85 a total finan-cial outlay of Rs. 101.180 lakhs has been provided.
