Will the Minister of EDUCATION be pleased to state:

- (a) whether Government are aware that the technical terminology evolved, by C.S.T.T. has failed to serve the contemplated purpose;
- (b) if so, what steps Government are taking to make this Terminology more useful for the cultural integration of the country; and
- (c) whether the Government Eire aware that at no stage the users were associated while evolving and finalizing the said Terminology and whether Government are now considering to associate the actual users—the Readers of the literature in which this Terminology is used and whether they will also be associated in evolving a Pan-Indian Terminology?

THE MINISTER OF EDUCATION AND SOCIAL WELFARE (SHRI S. B. CHAVAN): (a) No, Sir. The Commission for Scientific and Technical Terminology has so far evolved equivalents of about 4 lakh scientific and technical terms. With the help of this evolved terminology, over 1100 books have been got prepared for the teachers and students imparting and receiving education upto the degree level through the medium of mother-tongue in all disciplines. This was the main purpose for which terminology was evolved.

(b) Having achieved success in the programme of book production in Hindi using the terminology evolved by the Commission for Scientific and Technical Terminology, the scheme of evolution of Pan-Indian terminology has been launched to help the cultural integration of the country. Another scheme has been initiated to compile the Hindi equivalents of the common
