Distribution of Land in Gujarat State

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND RURAL RECONSTRUCTION (SHRI BALESHWAR RAM): (a) to (c) It is understood that some Adivasis from different States met the Prime Minister on the eve of last Republic Day and the Prime Minister assured them that their grievances regarding dispossession from land shall be remedied. The Government of India has requested the State Governments to ensure that allottees of ceiling-surplus lancT are not disturbed in their possession and evicted therefrom either by erstwhole owners or by other powerful interests.

THE MINISTER OF EDUCATION AND SOCIAL WELFARE (SHRI S. B. CHAVAN): (a) and (b) There have been some vague allegations about irregularities. NCERT has been asked to ascertain specific details so that the academicians concerned can be called upon to substantiate their allegations.

The working of NCERT has been periodically reviwed. The annual accounts of NCERT are audited by the Comptroller and Auditor General of India. The Audit Report and the Annual Report of NCERT are laid in Parliament every year.

Proposals have been received for opening Ken-driya Vidyalayas (Central Shcools) at Ahmedabad, Baroda, Bhavanagar and Junagarh, but these are not complete. Each of these proposals will be considered on merit after the concerned sponsoring authorities have fulfilled the prescribed terms and conditions.
