/c) At every stage of the work, the main users of the terminology i.e. University teachers and other experts were associated with the evolution of terminology. Over thousand active teachers and scholars hailing from every part of the country were associated in the fina-lisation of terminology evolved by the Commission for Scientific and Technical Terminology. It will be ensured that scholars who are the active users of this terminology are associated in the Pan-Indian terminology work also.

## Introduction of Intensive Agricultural Schemes

- 921. SHRI M. BASAVARAJU: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether it is a fact that rapid increase in population is putting greater pressure on cultivable lands in the country;
- (b) if so, whether Government propose to introduce intensive agricultural schemes; and
- (c) if the answer to part (b) above be in the affirmative, what are the details in this regard?

THE MINISTER OF STATE IN i'HE MINISTRY OF AGRICULTURE AND RURAL RECONSTRUCTION (SHRI R. V. SWAMINATHAN): (a) Yes, Sir. The per capita cultivable land has decreased from 0.41 hectares in 1960-61 to 0.29 hectares in 1977-78. The average size of holdings has also decreased from 2.30 hectares in 1970-71 to 2.00, hectares in 1976-77.

(b) and (c) Government is already implementing variolis Central and Centrally Sponsored intensive Agricultural Schemes for increasing production of foodgrains and cash crops. These are; (i) High-Yielding Varieties *r* Programme; (ii) Minikit-cum-Com-munity Nurseries Programme for rice; (iii) Minikit Programme of wheat, maize and millets; (iv) Schemes for intensive Development of Pulses; (v)

Intensive Oilseeds Development Programme; (vi) Intensive Cotton District Programme; and (vii) Intensive Jute District Programme.

## Misuse of Grants for Adoption of Orphans

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KARTIK ORAON): (a) and (b) The Divisional Boards are constituted and controlled by the R'egional P&T Sports Control Boards set up at 16 regions/circles of P&T Department throurhout the country. Many of the regions have already constituted their Divisional Boards and the majority of
