*137. SHRI K. CHATHUNNI MASTER:

SHRI K. C. SEBASTIAN:

Will the Minister of EDUCATION be pleased to state:

- (a) the names of the States where University Grants Commission scales for college and university teachers have not been granted;
- (b) what are the reasons for nonimplementation of the scales; and
- (c) what steps Government are taking t_0 ensure that the UGC scales are granted in all the States?

THE MINISTER OF EDUCATION AND SOCIAL WELFARE (SHRI S. B. CHAVAN): (a) The revised University Grants Commission scales have not been adopted by the Government of Kerala for university and college teachers in the State. The Jammu and Kashmir and Karnataka Governments have sanctioned these scales to university teachers only.

(b) and (c). Though the Central Government had agreed to provide financial assistance for adopting these scales for the period from 1-1-1973 to 31-3-1979, it is for the State Governments concerned to sanction them. The discretion is with the State Governments as they have to maintain the revised scales after the expiry of the period of Central assistance.
