THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRY (SHRI P. A. SANGMA): (a) to (c) While positive interest in the project has been shown by many leading automobile manufacturers of the world, detailed proposals have so far been received from M/s. Peugeot and M/s. Renault of France. Government have not notified any formal closing date for submission of offers. Reasonable time will be given to interested parties to submit detailed offers setting out, irater alia, the terms and conditions including the investment pattern. A decision will be taken after evaluating the offer<sub>s</sub> received.

THE PRIME MINISTER (SHRI-MATI INDIRA GANDHI): (a) and (b) Amongst other countries, Government  $ar_e$  negotiating with USA to replace and modernise some of our weapon systems. Negotiations are still continuing. It is not advisable to disclose details.

### State Industry Ministers' Conference

## •152. SHRI K. L. N. PRASAD; SHRI BHABANI CHARAN PATTANAYAK:

Will the Minister of INDUSTRY be pleased to state:

(a) whether it is a fact \*that the Conference of Ministers of Industry of different States wag held on the 8th February, 1981 in Delhi;

(b) if so, what were the subjects discussed;

(c) whether any decisions were arrived at;

(d) whether all the Ministers were in agreement for continuing District Industries Centres; and

(e) if so, what step<sub>s</sub> are being taken to implement the decision?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRY (SHRI P. A. SANGMA): (a) A Conference of Ministers of Industry of different States and Union Territories was held in New Delhi on the 7th February, 1981.

(b) and (c) Among the subjects discussed at the Conferences were: implementation of Industrial Policy and monitoring of industrial approvals, rationalisation of incentives, backward area development through nucleus plants, support for the small scale sector and re-orientation of District Industries Centres.

It was decided that State Governments would build up counterpart

mechanics to ensure monitoring and frution of letters of intent and licences for industrial projects. It was also agreed that incentive patterns should be individually tailored to the growth needs of different areas and concerted efforts will be made to set up nucleus complexes. Further discussion with Ministers of Industries will be held for evolving a consensus in regard to the criteria for identification of backward areas.

(d) and (e) As regards District Industries Centres, the main thrust of the discussion was on giving a new project orientation to them. There was general agreement that District Industries Centres should become the focal points of project conceptualisation and implementation at the district level.

### Manufacturing of small car in the Maruti factory

It is proposed to enter into an appropriate foreign collaboration for the purpose. r'
