- (b) if so, the extent to which the prices of edible oils rose during the last 6 months and what are the reasons therefor; and
- (c) what measures have been taken by Government to check the rising prices of edible oils and to make it available to the consumer at reasonable prices?

THE DEPUTY MINISTER IN THE MINISTRY OF CIVIL SUPPLIES (SHRI BRAJ MOHAN MOHANTY): (a) and (b) Yes, Sir, The wholesale price indices of major edible oils, except Coconut oil had shown an upward trend during the period from January, 1981 to July, 1981. The rise in the edible oil prices may be mainly attributed to fall in the production of oilseeds in the oil-year 1979-80. The shortfall in production encoraged speculative forces to operate, constributing to the bullish tendencies of oil prices.

- (c) The Government have taken several longterm as well as shortterm steps to stabilise the prices of edible oils in the country. Some of the important measures taken are:-
- 1. Encouraging production , σ ilseeds and planned efforts to exploit non-traditional sources so as to reduce the gap between demand and supply of oils;
 - 2. continuing imports of adequate quantity of edible oils;
 - 3. release of more imported oils for public distribution system;
 - 4. price-restraints on a voluntary basis by the vanaspati industry;
 - 5. maintenance of steady production of vanaspati;
 - 6. encouragement of greater production of cottonseed oil;
 - 7. request to State Governments to enforce Storage Control Orders and other enactments;
 - 8, free movement of oilseeds and oils between various part of the county; and

9. curb on illegal trading in oilseeds and oils by Forward Markets Commission through periodic raids.

Shortage of Vanaspati

267. SHRI K. L. N. PRASAD: SHRI KALRAJ MISHRA:

Will Minister of the CIVIL SUPPLIES be pleased to state:

- (a) whether it is a fact that there has been acute shortage of vanaspati in the country during the months of June and July, 1981;
- (b) whether imported edible oils allocated to the vanaspati industry and the public distribution system are being siphoned off to the open market at fancy prices;
- (c) if so, what are the findings of the enquiry, if any, held in the matter; and
- (d) what measures have been taken to make available vanaspati to the consumers at fair price?

THE DEPUTY MINISTER IN THE MINISTRY OF CIVIL SUPPLIES (SHRI BRAJ MOHAN MOHANTY): (a) No, Sir. On the other hand the production of vanaspati during June 15.4% higher and July, 1981 was than the corresponding period of 1980. In case of any sporadio ports about shortage of vanspati, Vanaspati Manufacturers Association were asked to rush supplies to the concerned areas.

- (b) and (c) No specific complaints have been received in this regard which could be enquired into, As regards imported oils given to vanaspati industry, their production is being monitored through returns and inspections by field officers. The State governments have been addressed to exercise constant vigilance that the oils supplied for public dstribution by State Trading Corporation of Inda reaches the consumers for whom they are meant at the pre-determined prices.
- continuing i_S (d) Government dialogue with the vanspati manufac-

turers regarding the availability of vanaspati in sufficient quantities and at the price announced by the industry, and would continue to take such appropriate steps as the situation demands from time to time. The State Governments have also been requested to keep a watch on the situation and to take effective measures to maintain vanspati availability and prices, in coordination with vanaspati industry and trade.

Master Plan on Rivers of North Bengal

- (a) whether Central Government have received master plan on any of the rivers of North Bengal from the West Bengal Government; and
- (b) if so, what are the details thereof?

THE MINISTER OF STATE THE MINISTRY OF IRRIGATION (SHRI Z. R. ANSARI); (a) and (b) No Master Plan for irrigation on any of the rivers of North Bengal has been received from the Government of West Bengal. However, preliminary Master Plans for flood control for rivers Teesta, Torsa, Jaldhaka and Raidak were sent by the West Bengal Government to Central Water Commission. Since these were not based on detailed surveys and investigations, Central Water Commission had requested the State Government to revise the Master Plans. The State Government have informed that it has not been possible to carry surveys and investigations as the Government of Bhutan did not give permission for surveys in their territory.
