THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIE. AHAMMED): (a) and (b) Pakistan had requested for experts from the Archaeological Survey of India (ASI) in May, 2005 to advise it on restoration of Katasraj Temple Complex. An ASI expert visited the Katasraj Temple Complex from 29th August to 2nd September, 2005 and submitted a report which was handed over to the Government of Pakistan in January, 2006. The restoration of the Temple Complex is being carried out by authorities in Pakistan. India has offered to provide further technical assistance, if required.

Construction of by-pass on National Highway No. 7

Tenders for this project on BOT Annuity basis have already been invited but the award of work is yet to be finalized. The land acquisition work is in progress.
