Tourism faster Plan for holy places

156. SHRI BALAVANT ALIAS BALAPTE:
SHRI VINAYKATIYAR:

Will the Minister of TOURISM be pleased to state:

- (a) whether Government have prepared Tourism Master Plan with emphasis on strategic planning for long-term tourism development with focus on infrastructure at holy places;
- (b) if so, the details thereof; and
- (c) the steps taken/proposed to be taken to implement the said plan?

THE MINISTER OF TOURISM (SHRIMATI AMBIKA SONI): (a) and (b) During the year 2002 and 2003, the Ministry of Tourism had commissioned 20-year Perspective Plan for the States/UTs, with the objective and promotion of tourism and development of tourist infrastructure in all areas, including holy/religious places. The Plans, *inter-alia*, evaluated the existing tourism scenario of the States, identified tourism projects, destinations and circuits along with requirements of infrastructures for their development. Besides evaluating the infrastructural requirement, the Perspective Plans have given an Action Plan for development of tourism in the States in the short and long terms.

(c) As the development and promotion of tourist spots/places in States/UTs is primarily the responsibility of State/UTs Governments concerned, the 20-Year Perspective Plans were forwarded to them for taking further necessary action for development of tourism. Central Financial Assistance is also given to the State Government to implement prioritized destination and circuit infrastructure improvement projects formulated by them. A Statement giving a list of projects sanctioned to the State Governments at holy/religious places during the year 2005-06 is enclosed.
