daily average number of loaded wagong made over by Western Railway to the Northern Railway was 697 775 and 883 on Broad Gauge and 616, 631 and 677 on the Metre Gauge. This indicates continuous increase in the flow of traffic from the Western side to the North The traffic from Western side to the North comprises mostly of petroleum products fertilizers, demand for which is increasing alround. Hence there been a spurt in demand of wagons especially for the above.
