- (a) whether it is a fact that serious seepages have been found in the Barna Dam in Madhya Pradesh;
- (b) what is the extent of the damage done so far; and
- (c) what remedial steps Government have recommended and implemented in strengthening and protecting the dam?

THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION (SHRI Z. R. ANSARI): (a) There has ben a problem of seepage in the Barna Dam.

- (b) There is no visible damage so far to the dam.
- (c) The Government of Madhya Pradesh have set up a Technical Committee to advise the remedial measures. The Committee, in its first meeting held in March, 1981 inter-alia, recommended grouting the foundations and grouting of some selected area of the dam masonry in order to test the effectiveness of the grouting in reducing seepage and uplift pressures.

The Chief Engineer Barna Dam has informed that the work of grouting has since been awarded.

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND RURAL RECONSTRUCTION KAMALA KUMARI): (a) Yes, Madam.

- (b) Under this scheme raising of fuelwood plantations on village common lands, Government Waste lands, degraded forests, on sides of roads, canals and railwayline, etc. has been prescribed. The species to be planted are to be fast growing and about 1500 plants are to be planted per ha. Under this scheme well grown seedlings of suitable species are to be supplied free of charge to farmers for planting in their farms and to children for planting under "A Tree f>Jr Every Child1' programme. The seedlings to be supplied to the children are to be fruit trees.
- (c) An amount of lis. 29 crores has been allocated for Himachal Pradesh and Rs. 13.6 crores to the hilly regions of Uttar Pradesh for forestry development including planting of trees during the State Sixth Five Year Plan Period. In addition, under the Centrally Sponsored Schemes 'Social Forestry' and 'Soil Water and Tree Conservation in the Himalyas' an amount of Rs. 4.42 crores for Himachal Pradesh and Rs. 6.33 crores for the billy regions of Uttar Pradesh has been earmarked as Central grant during the Sixth Five Year Plan.

Rise in the prices o* essential commodities

198. SHRI LADLI MOHAN NIGAM: SHRIMATI AZIZA IMAM: SHRI D. HEERACHAND. SHRI B. C. PATTANAYAK:

Will the Minister of CIVIL SUPPLIES be pleased to state:

(a) whether Government are aware that the prices of all essential commodities have registered phenomena! increase during the last one month;

- (b) if so. what are the reasons therefor; and
- (c) what steps Government are taking to check their prices?

MINISTER DEPUTY IN THE THE MINISTRY OF CIVIL **SUP PLIES** (SHRI **BRAJMOHAN** MOHANTY): (a) There has been a mixed trend in the prices of various essential commodities during March. 1981 over February, 1981 in as much as the wolesale price indices of some~~ commodities have increased some have declined and some others remained steady.

- (b) The rise in prices of some essential commodities, apart from the general inflationary pressures in the economy, may be attributed to after effects of the unprecedented drought of 1979, fall in production of some essential commodities, increase in the prices of petro-products, increase in the administered prices of steel and coal, increase in support/procurement prices and the seasonality factor.
- (c) The main thrust of the Government policy to curb Ifne rising trend in the prices of essential commodities is to increase production. The public distribution system is: being expanded. Arrangements for import of edible oils for the current oil year have been made to ensure supplies through the public distribution system. The export of essential commodities is being regulated 3nd some essential commodities in short supply are being imported. The credit policy continues to be restrictive. The provisions of the Essential Commodities Act and Orders issued under it as well as the Prevention of Blackmarketing and Maintenance of Supplies of Essential Commodities Act, 1980 are being enforced vigorously by the States.
