. Working of Delhi-Patna Telephone Line

239. SHRI SHIVA CHANDRA JHA: Will the Minister of COMMUNICATIONS be pleased to state:

- (a) the number of times the telephone line between Delhi and Patna remained out of order during the last two months;
- (b) what are the reasons for Delhi-Patna trunk telephone line remaining out of order most of the time; and
- (c) what steps Government have taken to keep this line in order?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KARTIK ORAON): (a) There were only three occasions during February, 1981 and March, 1981 when all the Trunk Circuits from Delhi Trunk Exchange to Patna were out of order.

(b) The failure of the circuits was due to equipment mal-functioning. The total outage time when all circuits to Patna were out of order cannot be considered to be excessive considering the length of the circuits.

- (c) (i) Regular maintenance tests on the equipment are being carried out as per schedule to maintain satisfactory equipment performance.
- (ii) Back up transmission media have been provided between New Delhi and Patna to minimise the outages due to equipment faults etc.

Assessment of Additional Requirements of Foodgrains

Will the Minister of AGRICULTURE be pleased to state:

- (a) whether in view of the current growth rate of population in the country, Government have made any assessment with regard to the additional requirements of foodgrains each year to meet the situation; and
- (b) if so, what are the details thereof and the manner in which Government propose to meet the foodgrain requirements to outpace the current growth rate of country's population?

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND RURAL RECONSTRUCTION KAMLA KUMARI): (a) and (b) Yes, Sir. In the context of the Sixth Five Year Plan the total requirement foodgrains, keeping in view the growth in population and in private consumption expenditure etc. has been assessed at 150.6 million tonnes by 1984-85. The target of foodgrains production under the Sixth Plan has been fixed at 153.6 million tonnes. This implies a compound growth rate of 3.9 per cent per annum over the base level figure of 127.9 million tonnes (trend estimate). This order of growth is significantly above the current growth rate of country's population. The main strategy for achieving the above level of foodgrains production will comprise improvement in productivity as well as increasing the gross cropped area. The measures envisaged for stepping up productivity include: --

- (i) Expansion of area under assured irrigation and full utilisation of available irrigation potential;
- (ii) Expansion of area under high vielding varieties of crops:
- (iii) Optimum use of fertilizers; both organic and inorganic;
- (iv) Adequate plant protection measures to reduce crop losses due to pest and disease attacks;
- (v) Greater emphasis on soil and water conservation measures improved dry land framing practi-
 - (vi) Promotion of research and its application on a wider scale;
- (vii) Farmers training and educathrough re-organised strengthened extension net-work:
 - (viii) Development of the infrastructure of credit, marketing and distribution system for the supply of inputs and services; and
 - (ix) Providing remunerative prices for agricultural produce.

Construction of Houses in Punjab State by HUDCO

- (b) 47 schemes sanctioned HUDCO in the State of Punab include urban development, police housing, rural housing, urban housing, plotted development and site and services schemes. Total loan sanctioned HUDCO is Rs. 25.02 crores and the project cost of all these schemes is Rs. 36.72 crores.
