# MOTION RE. PUNISHMENT TO PERSONS WHO RAISED SLOGANS IN THE VISITORS' GALLERY

MR. DEPUTY CHAIRMAN: Now the Leader of the House to move the Motion.

श्री जगदीश प्रसाद माथुर : (उत्तर प्रदेश) : श्रीमन, मेरा एक प्वाइंट है। इस से पहले कि मंत्री जी प्रस्ताव रखें मुझे आप मौका दीजिये।

MR. DEPUTY CHAIRMAN: I will allow you. Nothing is lost. Let us proceed with the business.

MR. DEPUTY CHAIRMAN: That will not be together. I assure you.

THE LEADER OF THE HOUSE (SHRI PRANAB KUMAR MUKHERJEE): Sir, I beg to move the following Motion:

"That this House resolves that the persons calling themselves—

who raised slogans in the Visitors' Gallery of the House at about 12.20 PM today, the 18th March, 1982, and whom the Watch and Ward officers took into custody have committed a grave offence and are guilty of grave contempt of this House.

This House further resolves that they be sentenced to simple imprisonment till 12 Noon on the 24th March, 1982, and detained in Tihar Jail, Delhi."

The question was proposed.

SHRI M. KALYANASUNDARAM (Tamil Nadu): I want to know from the Leader of the House, who organised it, how did it happen, who are the Members who issued passes for these people? Can he enlighten the House as regards these matters? Who are the Members who issued passes? Did they offer any explanation for this? As a Chairman it is your duty to call the Members who have recommended passes for such persons and it is for them to behave. What have you to say? If I have committed a mistake, it is a breach of privilege of this House committed by a Member of the House.

DR. BHAI MAHAVIR (Madhya Pradesh): Sir, I had the occasion to comment on the incident which took place in the Visitors' Gallery today and on my personal behalf as well as on behalf of the party to which I have the honour to belong I had said that we do not approve of such a thing although we do feel that the subject which was agitating these young men is a very genuine one and the slogans that they were shouting did have a great amount of justification, but I had added that what is not justified, is the manner of expression of their sentiments which they had adopted. After that the Leader of the House, summing up the thing, had mentioned that the Member under whose signature the passes had been issued should express regret before the House and I spontaneously said that I agreed with him wholeheartedly in this matter. I had no notion at that time and I stand here to admit that subsequently I was told by the Secretariat staff that some of the young men who had indulged in this incident had been issued passes on which my signatures were appended. Sir, I regret the manner in which the passes were issued, but I would like to say that I had no notion at all, absolutely, about what their intention was. People do come to us. Sometimes they come to us and say that they are students from here or outside wanting to witness the House. Only the other day some three or four people came from Agra and they said to me that they wanted to see that Parliament in session, they wanted to see the Lok Sabha, I said, I was not a person who could issue a pass for Lok Sabha. "All right", they said, "could you issue us a pass for Rajya Sabha?" Similarly, there have been others. Once some six persons contacted me and said that they were going back that evening, so I should oblige them. Well, Sir, when we sign a form like this we are accepting the responsibility for their conduct. (Interruptions). What is provoking Mr. Kalp Nath Rai? What are you inciting your members

to do? I am admitting that if there are people who have come to the visitors gallery on the basis of forms issued under my signature, it was inadvertent on my part, but the only explanation I can give is that when the people come to us, there is no manner of knowing if they had any such thing in mind. If at all I had known, obviously I would have been the last person to encourage this or to permit them to use my signature for this purpose. Since the hon. Member here has raised the question, I found it necessary; otherwise, if the Resolution had been passed put to vote we would have supported them as we have already said, irrespective of the merits of the demands which those young people were raising. So, in this matter, as I said, I do express my regret that my signature appeared on that. But I would solemnly affirm that this thing was not known to me or to my other friend whose signature appeared on the forms of some of these people. But, in this matter I would reassert that our group with the small representation that we have in this House, our behaviour all along in this House is such that nobody has ever had an occasion to point an accusing finger against it. So, if something has happened, it has been through inadvertence and that also because it is not possible to verify. We are coming into contact with thousands of people and when they come for a favour like this, it is not possible to go into the depth of their hearts and find out what exactly their intentions are. We do not approve of this incident and we heartily regret that something of this type should have happened which has besmirched the dignity of this House. Thank you.

**श्री कलराज मिश्र (उत्तर प्रदेश) :**

श्रीमन्, सम्माननीय डा० भाई महावीर जी ने जो बात सदन में रखी है, मैं समझता हूँ कि इसके पहले जिस प्रकार की घटना हुई है उसकी सब ने भर्त्सना की है।

मैं भी उसमें सहभागी हूँ। संयोग से जो पासेज बने हैं वह भरे हस्ताक्षर से भी बने। मैंने उसको देखा है और जिस प्रकार से लोगों ने दस्तखत करा कर यह किया है वह सामान्य—तौर पर अक्सर लोग आते हैं। दर्शक वीर्षा में बैठ कर राज्य सभा की कार्यवाही को देखने की लोगो में सामान्य तौर पर उत्सुकता होती है। उसी प्रकार से हमने भी दस्तखत किये थे हमें इस प्रकार की घटना इनके द्वारा घटित होगी, कल्पना मात्र तक भी नहीं थी। जैसा कि डाक्टर साहब ने हाउस के समक्ष यह विचार प्रकट किया है कि उन्होंने जो स्लोगन्स लगाये उनके आचित्य के बारे में तो किसी को इंकार नहीं हो सकता, लेकिन उन्होंने जो माध्यम चुना यह माध्यम उचित नहीं था, वह फोरम उचित नहीं था। इसकी सब ने एक स्वर से भर्त्सना की है। चूंकि इसमें हमारा नाम था, पासेज इश्यू किये गये थे और उसमें एक व्यक्ति हमारे द्वारा दिये हुए पास से आये थे इसलिए मैं स्वीकार करता हूँ कि हाउस के बीच में यह बात हुई है, उनकी इस प्रकार की मनोवृत्ति के बारे में कि वे इस प्रकार की घटना करेंगे, किंचित भी जानकारी नहीं थी। इसलिए मैं हाउस के सामने अपनी बात स्पष्ट रखना चाहता था और वह मैंने रख दी है।

श्री सैयद रहमान अली (आंध्र प्रदेश) : जनाब, मैं एक अर्ज करना चाहता हूँ। यह बड़े दुख के साथ कहना पड़ता है कि इस हाउस के दो मुअज्जिज मेम्बरों ने इस नाखुश वाक्य पर सिर्फ रिप्रेट का इजहार किया है। सिर्फ अफफसोस का इजहार करने से इस हाउस की इज्जत और वकार को धक्का लगा है और उसको भुत्तमिन नहीं किया जा सकता है। मैं इन दोनों बुजुर्ग मेम्बरों से यह दर्खास्त

करना चाहता हूँ कि वे इस हाउस में

SHRI R. RAMAKRISHNAN (Tamil  
Nadu): We want to support the Mo-  
tion. We have the right to condemn  
the incident.

SHRI R. RAMAKRISHNAN: While supporting the Motion moved by the Leader of the House...

MR. DEPUTY CHAIRMAN: No, please... (Interruptions)...

SHRI R. RAMAKRISHNAN: We have got a right to be heard.

MR. DEPUTY CHAIRMAN: I cannot stop anybody.

SHRI R. RAMAKRISHNAN: Not like that. Our party did not speak in the morning. We kept quiet because you wanted to adjourn the House.

MR. DEPUTY CHAIRMAN: You support it.

SHRI R. RAMAKRISHNAN: We want to condemn. Silence cannot be taken as support. Some people are quiet all the time. How can you take them for granted? It is not a good attitude. Because most of the time we are quiet, you take us for granted—which we will never tolerate. But now, Sir, this is a very serious matter...

MR. DEPUTY CHAIRMAN: Mr. Ramakrishnan, I object to this thing really. It was announced in the House. I think you might have been there.

SHRI R. RAMAKRISHNAN: I came there also.

MR. DEPUTY CHAIRMAN: Your consent is not presumed. I don't take anything for granted...

(Interruptions)

SHRI R. RAMAKRISHNAN: The motion is before the House. Two Members have expressed regret. I want to say something.

MR. DEPUTY CHAIRMAN: They have expressed regret for signing for the visitor's card. I did not allow anybody to speak.

SHRI R. RAMAKRISHNAN: Unqualified regret was to be expressed. It is not enough to say that somebody came to me and I didn't know. I don't blame them, their *bona fides* or anything like that. But we, as hon. Members of this House, should take great care before we sign for some people so that incidents of this nature which will spoil the dignity of the House should not occur. This is my only plea. I support the motion of the Leader of the House.

SHRI M. KALYANASUNDARAM: One submission, Sir. The resolution will have to be put to vote...

(Interruptions)

SHRI PRANAB KUMAR MUKHERJEE: Sir, I have an amendment. In fact, I mentioned eleven names but actually the names are fourteen. Therefore, I am reading three additional names: Karan Singh Tanwar, Bharat Deep and Harjeet Singh. Therefore, these three names should be taken together with the eleven names which I have already mentioned. These are the fourteen persons concerned.

SHRI M. KALYANASUNDARAM: Sir, the motion must be unanimously approved. That was the understanding and I hope it will be unanimously carried. At the same time, I am very sorry that we have to punish these youngmen for their behaviour. Their demand may be right. If the same people had agitated outside and even thought of picketting Parliament, we would have supported their demand, but the course they have adopted is wrong. At the same time I would appeal to the Government to go deeply into the matter and set right the cause which gave rise to this agitation.

MR. DEPUTY CHAIRMAN: I will let the House know the names of the Members who signed because there are some more signatures on the paper. I am sorry the office did not

prepare the names: I really don't like that. They should have prepared a list of all the names of those who had signed the papers... (Interruptions)... There are some more persons and I will let you know it later on. ... (Interruptions)... The names are not legible. I will have to take them from the division numbers. That will require some time. Now the names have been read.

SHRI HAREKRUSHNA MALLICK (Orissa): We want to know all the names.

MR. DEPUTY CHAIRMAN: I will tell you. I have just told you that the names are not available. I have to get them tallied with the division numbers. The office should have been ready with them, but I am sorry.

SHRI M. KALYANASUNDARAM: After ascertaining the actual list of the persons because we are condemning those persons by name.

SHRI PRANAB KUMAR MUKHERJEE: Just one minute. I would like to clarify the position. There are two aspects. One aspect is that some Members introduced the visitors to the gallery. With that we can deal ourselves. It is a matter among the Members, ourselves. Dr. Mahavir and hon. Mishraji voluntarily came forward and expressed their regrets. So, this is a matter within ourselves, so far as the Members of the House are concerned. But there is another operative part which I mentioned in the motion itself. Therefore these two things should be delinked. As to the other Members who introduced, as the office is not in a position to identify the Members simply because the signature is not legible, it will have to be tallied with the division numbers. Therefore, they can do it tomorrow or sometime in the latter part of the day. But this thing should not be held up.

SHRI M. KALYANASUNDARAM: Is the list of accused complete? (Interruptions)

SHRI HAREKRUSHNA MALLICK: Sir, I rise on a submission. Our office cannot be so incompetent as not to tell us...

MR. DEPUTY CHAIRMAN: Some more Division Nos. are there perhaps.

SHRI PRANAB KUMAR MUKHERJEE: Here I would like to request the hon. Members one thing. Their Leaders were present in my room. It was our unanimous view that we should not have any debate on it. Therefore, let us agree to it and I would request Shri Shiva Chandra Jha not to insist on any amendment.

SHRI SHRIDHAR WASUDEO DHABE (Maharashtra): Because we were all there in the chamber of the Leader of the House and there we discussed it and all of unanimously agreed that such a motion should come up, now it will not be proper for us to discuss the details of the motion which we want to adopt. So far as the MPs are concerned, the matter can be taken up later. It is a very correct motion. I support the motion moved by the Leader of the House.

DR. BHAI MAHAVIR: Sir, unfortunately, I had expected that the motion would be enough and it would be passed without much discussion, but since on one point or the other some discussion has started now, I may be permitted to submit one thing, that I also have a feeling that the offence committed should not call for this severe punishment. But if our friends have agreed about it, it is all right. There have been occasions, Kalp Nath Raiji, when certain things happened in the other House and I suppose here also, but at no time was the penalty so severe. Mostly it is for

the day's duration; they were detained and afterwards they were let off. But this is not the thing. I think the young people who came forward did for a public cause and I would submit, Sir, that the Government has to apply its mind to see that this thing does not keep on worrying the people, the citizens of the country, that the Government is not interested in holding elections where the party in power fears a defeat.

**SHRI BUDDHA PRIYA MAURYA** (Andhra Pradesh): Mr. Deputy Chairman, this is too much. This is not the occasion to talk like this.

**DR. BHAI MAHAVIR:** It is not an occasion certainly, but since some discussion has started, I am only putting the record straight, that when I regretted, I did not mean that I did not wholeheartedly support all the sentiments that the young people have. That is something apart. But if the hon. House thinks that there is agreement about seven days' penalty well, it is quite all right. The House can reconsider if it feels like that later on, but let it be passed; there is no objection to that.

श्री जगदीश प्रसाद माथुर (उत्तर प्रदेश) : श्रीमान्, एक गम्भीर विषय पर हम लोग चर्चा करना चाहते थे लेकिन इस बीच एक अवांछनीय घटना हो गयी मैं समझता हूँ कि मैंने बात यह कही थी मैं मंत्री महोदय को बधाई देता हूँ कि उन्होंने जरा देर में ही कहा लेकिन हमारे डाक्टरों की प्रशंसा की, उनकी पीठ थपथपायी । यह दुर्भाग्य है कि हम लोग इस विषय में ऐसे अड़े हैं । एक तरफ हमारे महयोगी ने कुछ कह दिया और उसके प्रतिक्रिया स्वरूप हमारे देश के ऐसे डाक्टरों ने जो बड़े योग्य हैं, विद्वान हैं और हमारे देश के गौरव के प्रतीक हैं उनको त्यागपत्र देने की मजबूरी आ गयी इसमें से कुछ दो चार लोगों को मैं व्यक्तिगत रूप से जानता हूँ डाक्टर गोपीनाथ जी हैं, डाक्टर वेणु गोपाल हैं या और दूसरे मेरे साथी हैं यद्यपि उनका इस मामले में कोई विशेष संबंध नहीं है । डाक्टर राजेंद्र प्रसाद आप्थल्मिक सेंटर के डाक्टर मदन मोहन हैं ये वे लोग हैं जिन्होंने अपने कर्तव्यों से, निष्ठा से देश के स्वाभिमान और गौरव को बढ़ाया है । अब यह घटना क्यों हुई, इसका विवेचन करना विशेष फायदेमंद नहीं होगा । मैं मंत्री महोदय के साथ अपनी आवाज मिलाना चाहता हूँ कि ये दोनों डाक्टर अपना त्याग पत्र वापस ले लें उन्होंने जो इरादा त्याग पत्र देने का दिखाया है उसे वापस ले लें । अब या तो मेरी जानकारी गलत होगी अथवा मंत्री महोदय भूल गये कि एक और डाक्टर है, डाक्टर आई एम राव, इन्होंने भी शायद मेरी जानकारी के अनुसार त्याग पत्र दिया है या देने की इच्छा प्रकट की है । यही बात उनके साथ भी
