STATEMENT BY MINISTER

Attack on UJ5. Consulate-Generars Office it Bombay

MR. CHATRM/N: Shri Laakar to make a mo moti statement.

THE MINISTEI OF STATE IN THE MINISTRY SF HOME AFFAIRS (SHRI NIHAR]; ANJAN LASKAR): Sir, according U a report received from the Govern nent of Maharashtra at about 4.46 px.. on March 25, 1982, four persons we it to the US Consulate-General's Office at Bhulabhai Desai Road, Bombay, and asked for some import-e> port forms. When told that such f >rms were not available, two of the persons started attacking the Consu' ate staff with plastic containers with lighted wicks. Forty others from 0 itside rushed in and started smashin; the window panes of parked cars »nd setting them on fire. Four cars ivere burnt and seven were damaged They also damaged furniture, flower pots and window panes of the building The police guards on duty opened fire resulting in the death af one person. Thirty persons including their leader Bandu Shingre were arrested. T>ie miscreants threw leiffets purporting to have been issued by an organisation called Azad H*id Sena. Investiga-(ti"n of the cas> is in progress. The Chief Secretary hag assured the US Consulate Geniral at Bombay of full protection for the Consulate.

The Government greatly deplore the incident. The Ministry of Kx-ternal Affairs have conveyed their regret over the incident to the American Ambassador in New Delhi.

SHRI LAL K. ADVANI (Gujarat): Who were the persons involved? Do they have any political affiliations or links. Or, has there been any contact between them and the Consulate there?

SHRI NIHAR RANJAN LASKAR: We are trying to collect all this information. Only this is the information with me
