- period for which (f) the average posts filled during 1981 remained vacant or unfilled?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI JAGAN NATH KAUSHAL): There were 77 vacancies of Judges and Additional Judges as on 1-1-1981.

- (b) During 1981, 30 vacancies of Judges and Additional Judges arose.
- (c) 3 posts of Judges and Additional Judges were created in 1981.
- (d) 32 posts of Judges and Additional Judges were filled up during 1981.
- (e) There were 78 posts of Judges and Additional Judges vacant as on the 31st December, 1981.
- (f) The appointment of Judges is a continuous process as vacancies keep on occuring and States authorities send proposa's from time to time.

THE MINISTER OF LAW. JUSTICE AND COMPANY AFFAIRS (SHRI JAGAN NATH KAUSHAL): (a) 87 Reports.

(b) to (e) Each Report of the Law Commission deals with a particular topic or a particular Act. The Reports contain various recommendations, some indicating that no change in the law is necessary, some containing general recommendations of policy or administrative dures for the guidance of government In addition, while examining a particular Act, the Commission suggestions or recommendations with regard to other enactments which would have to be dealt with separately.

While the Report as a whole and the recommendations are examined, no arithmetical tally is kept of the total number of what could be characterised as recommendation in each Report. Hence information with regard to the arithmetical total of the number of recommendations contained in all the 87 Reports is not available.

All recommendations in a Report as a whole are taken into account while examining and processing the Report concerned administrative the

Ministries. However, certain recommendations or Reports do not call for any legislative action.

Further, the lapse of time after the submission of certain. Reports has made it necessary to have the problems considered afresh in the light of subsequent developments in the law in India and elsewhere as also the changes in social and economic conditions.

The detailed position with regard to the implementation of the Commission's Reports is as follows:

Out of 87 Reports submitted by the Commission, 33 have been implemented in full. In respect of 5 Reports no legislative action is necessary. Three Reports have been implemented in part. In respect of 11 Reports, a decision has been taken not to proceed with legislation for the present. The remaining 35 Reports are in various stages of processing. A Statement giving full details, is annexed. [See Appendix CXXI Annexur, No. 27].
