Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) what is the total expenditure incurred for the filmotsav '82 held recently in Calcutta;

(b) what are the names of the foreign countries who participated in that and how many films were screened;

(c) whether Government propose to consider Trivandrum as the venue for the next Filmotsav '82; and

(d) whether Government propose to arrange to screen the Indian films shown under Indian panorama in Filmotsav '82 in all State capitals?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI VASANT SATHE): (?) The approximate expenditure incurred on the Filmotsav '82 at Calcutta is Rs. 39.69 lakhs this includes actual expenditure as on 31st January, 1982 of Rs. 21.15 lakhs and liabilities amounting to Rs. 18.52 lakhs. Apart from this an expenditure of approximately Rs. 0.45 lakhs was incurred on the exhibitions & seminar organised during Filmotsav '82. However, these figures of expenditure are approximate and subject to Audit.

(b) A total of 104 foreign features and 32 foreign short films were screened in the festival. The names of the countries which participated in the festival are; Argentina, Austria, Bangladesh, Belgium, Benin, Bhutan, Brazil, Bulgaria, Cameroun, China, Congo, Cuba, Czechoslovakia, Denmark, Finland, France, F.R.G., G.D.R.
