on or before 31-8-1978, and which have completed the erection of their plants and have provided the necessary facilities to the satisfaction of l'ndian Oil Corporation and the State Directorate of Industries are considered for allotment of slack wax. The paraffin wax produced haa also to be of a quality acceptable to ISI.

Oil flnd_s in the new structure B-57 off-Bombay High

- 767. SHRI M. R. APPAROW: WiH Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:
- (a) what is the quantity of oil found in the 'new structure B-57 off-Bombay High;
- (b) how far it will help our country in achieving stelf sufficiency;
- (e) what will be the deficit in our oil requirements after the new discoveries; and
- (d) whether there is any prospect of attaining self sufficiency in our oil requirements in the near future?

THE MINISTER OF PETROLEUM, CHEMICALS AND **FERTILIZERS** (SHRI P. SHIV SHANKAR): (a) In the first well jn this structure oil flowed at a rate of 1030 barrels per uray before acidisation. Production testing nas been completed in the sec&id well and has confirmed the presence of hydrocarbons. The third well is under drilling. It wiH be necessary to drill a few more wells to assess the production potential of this field.

- (b) and (c) At the end of Sixth Plan period, the ONGC and OIL together are expected to produce Nearly 30 million tonnes of oil and 4 million tonnes of oil equivalent of gas, which ia expected to be about 70% of the total requirement of hydrocarbons at that time.
- (d) while every efTort is being made to increase the offshore and onshore Production, it i_s not possible

at this stage to predict complete selfsufficiency in the near future from the presently discovered reserves/ fields

THE MINISTER OF PETROLEUM. CHEMICALS AND **FERTILIZERS** (SHRI P. SHIV SHANKAR): (a) and (b) It has been decided to award Saurashtra Offshore Block II to M/s. Chevron, an Oil Company of U.S.A. A detailed agreement with the company is in the final stages of negotiations.
