MR. CHAIRMAN: He wants certain kinds of suits to bear court fees.

SHRI JAGANNATH KAUSHAL: All these matters wiH be considered after I know the views of the States.

MR. CHAIRMAN: Court fee_s in England were originally paid to the Judges and they were doing the work quickly. (*Interruptions*)

SHRI N. K. P. SALVE; It is a dangerous idea. (Interruptions)

MR CHAIRMAN; Judges were not asked to do the work quickly, but only those who did more work got more of the court fee.

SHRI JAGANNATH KAUSHAL: All these matters as I have already said, may be examined after I get the views of the States.

SHRI NARASINGHA PRASAD NANDA: Sir,...

MR. CHAIRMAN; Mr. Nanda and then Mr. Banerjee, and then we pass on to the next question.

SHRI NARASINGHA PRASAD NANDA: Sir, is Jt_a_ fact the sub-Committee particularly examined the question of revenue from court fees, and on authentic material supplied by the Government, came to the conclusion that the proportion of income from court fees which bears to the total revenue is negligible—almost 0.1 per cent? Is it correct?

SHRI JAGANNATH KAUSHAL: This is correct.

MR. CHAIRMAN: But it i_s a paying concern. You do not know that. 1 have dealt with this as the Chief Justice. Mr. Banerjee.

SHRI B. N. BANERJEE: As the Law Minister explained, and I also know it, court fee is a State subject, and therefore any legislation on the subject will involve the States agreeing to this particular point of viewabout the abolition of the court fee. I would like to understand the position. The Law Minister can choose any State he likes—any State. What

is the total amount of court fee which is recovered in a year in respect of that State—he can choose any State—and what is the total expenditure on administration of justice in that State? And what is the total revenue earned by the Government in a year in that State, to enable us to understand the problem?

(a) and (b) Details of the proposals for electoral reforms received on various occasions from the Election Commission which affect almost all

aspects of election law had already been placed OR the Table of the House in connection with Rajya Sabha Unstarred Question No. 44 dated 9th June, 1980 and Rajva Sabha Unstarred Question No. 564 dated 24th November, 1980. Some recommendations of the Commission are also contained in its Report on the General Elections to the House of the People and the Legislative Assemblies, 1979-80 and Vice-Presidential Elections, 1979-Volume I, which was laid on the Table of the House on 22-12-1980. The proposals are presently under consideration of the Cabinet Committee on Electoral Reforms. After provisional sions have been reached by the Committee, these proposals would be discussed with political parties and wherever hecessary, with State Governments as well. Hence taking of final decision would necessarily take some more time and it is not possible at this stage to indicate the time by which the proposal may be finalised

SHRI LAL K. ADVANI; Sir, on a point of order. He has referred to a number of questions earlier in 1980-81. I am wanting to ask supplementaries $o \mid i$ this particular question. SHRI LAL K. ADVANI; Yes, all right.

MR. CHAIRMAN: Will that be all right?

SHRI LAL K. ADVANI; If the answers given to the earlier questions are provided to us, it will facilitate; otherwise, at the moment I cannot even refer to them.

MR. CHAIRMAN: If the earlier question and the reply are put as an annexure, I think, that will be better

SHRI JAGDISH PRASAD MATHUR: Sir, in view of what has been said now, the Minister may put the material o_n the Table of the House and the question may be deferred to the next day so that we may ask supplementaries...

SHRI V. B. RAJU: Sir. the hon. Minister has said that there is a subcommittee going through all these recommendations or suggestions. May I request the Minister to see that these things are also placed before the sub-committee and not only the Election Commission's recommendations or suggestions as such, but also what the Parliamentary Committee in 1972, a decade ago, had said when it had prepared an elaborate report and submitted recommendations? These recommendations also should be placed before the sub-committee. Will the hon. Minister consider the question of placing these two items also before the sub-committee as money is playing its worst part in the elections? Will the Government be pleased to place them before the sub-committee for consideration of amendment of the Representation of the

People Act, so that no other person shall incur any expenditure on behalf of the candidate except through the election agent of the candidate, and find out whether an amendment of this nature could be made in the Representation of the People Act as it is available or obtaining in the U.K.? Today the position is that a group of people can join as supporters, as helpers, collect money and incur any expenditure for which the candidate ioes not submit any statement of expenditure. The Parliamentary Committee also had made a suggestion of this nature for the purpose of strengthening the party-system in this country. I would like to know whether the Government will be prepared to provide statutorily financial assistance to the parties, recognised parties, depending upon their performance in the earlier elections. A suggestion of this type was made by the Parliamentary Committee to the Government. Will these two things also be placed before the sub-com-

MR. CHAIRMAN: The suggestions are there.

SHRI JAGANNATH KAUSHAL: The proposals which are there, they are not based only on the proposals by the Election Commission. The proposals which are there are based on various suggestions which have been made by the committees and the suggestions which have been given by the political parties. All these matters are being examined.

MR. CHAIRMAN: These may also be noted.

SHRI V. B. RAJU: These suggestions also may be examined.

SHRI MURASOLI MARAN: Sir, article 324 provides for the appointment of more than one Election Commissioner; in that case only one will act as a Chief Election Commissioner. I do not know for what reason there is only one Election Commissioner and he is also designated as the Chief Election Commissioner. To call the

sole Election Commissioner as the Chief Election Commissioner, I think, is a misnomer. So, I would like to know from the hon. Minister whether there is a suggestion from the Election Commission itself or from other quarters to appoint more Election Commissioners and regional commissioners, as provided in article

SHRI JAGANNATH KAUSHAL: I must again submit to the House that those points have been raised by people from time to time, namely, whether there should be more than one Election Commissioner. All these matters are under consideration.

MR. CHAIRMAN: Last question, Mr. Mathur.
