Immediately after the detection of the contaminated glucose, on 21-12-81, a complaint was lodged with the Drugs Controller, Delhi Administration. A Drug Inspector visited the All India Institute of Medical Sciences on 5-1-82 and took away the contaminated bottle for analysis. Further purchase of I. V. fluids from M/s. Dhavsons Pharmaceuticals was also stopped by the Institute. The Drug Inspector again visited the Institute on 18-2-82 and took away the contaminated bottle for analysis. In both the instances, the contamination was discovered before administration of the fluid to patients. As per standing instructions of the AIIMS hospital, I. V. fluids are to be inspected by the Nursing Staff before being administered.
