- (c) the details of the service provider(s) or insurance company(ies) identified for implementing the scheme and the criteria evolved for selection of the service provider(s)?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI PANABAKA LAKSHMI): (a) No, Sir.

(b) and (c) In view of reply to (a) above, the questions do not arise.

Procurement of anti Bird Flu drugs

3135. SHRI SURESH BHARDWAJ: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that anti Bird Flu drugs were procured by Government from a license holder of Roche, the German drug multinational company;
- (b) if so, the procedure followed to select the drug company and the price negotiated for the supply of drugs;
- (c) whether an Indian Pharma Company claimed to supply the same drugs at much lesser price; and
 - (d) if so, the details thereof and the reasons for not selecting them?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRIMATI PANABAKA LAKSHMI): (a) Yes, Sir.

(b) and (c) Government of India took a decision to stockpile one lakh courses of Oseltamivir. At that point of time M/s. Roche, Switzerland was the only manufacturer of the drug. M/s. Roche have supplied 30,000 packs of Tamifle (Oseltamivir) at a special concessional price of Rs. 852/- per pack. M/s. Hetero Drugs Pvt. Ltd. An Indian Pharmaceutical Company. Subsequently obtained license to manufacture the drug. 70,000 packs of Oseltamivir capsules have been procured from M/s. Hetero Drugs Pvt. Ltd., Hyderabad, @ Rs. 710/- per pack (10 capsules per pack).
