

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI TASLIMUDDIN): (a) The National Commodity and Derivatives Exchange (NCDEX), Mumbai did not exist in early sixties and was never banned. The Government granted recognition of NCDEX on 20th November, 2003 on a permanent basis. The Exchange commenced its operations on 15th December, 2003.

(e) The reasons for rise in prices of pulses and staple commodities are mainly shortfall in domestic supply relative to demand and hardening of international prices of certain foodgrain items. Main benefits from futures trading at the commodity exchanges including at NCDEX are price discovery and the facility for price risk management by various categories of persons such as farmers, manufactures, exporters, consumers etc.

However, estimates of paddy/rice procurement in each State (combined for FCI and State Agencies) are drawn up in a meeting of State Food Secretaries held before each Kharif Marketing Seasons (KMS). These estimates for West Bengal for last five years including the current KMS 2005-06 alongwith achievements made by FCI and State Agencies are enclosed at Statement.
