Tile mineralisation has been intermittently traced over 2.5 kilometres strike length. Mineral Exploration Corporation Limited plans to do 1500 metres of drilling and associated geological work at an estimated cost of Rs. 11.5 lakhs. The drilling work in Gorubathan started in October, 1981. and till 15'h February, 1982. 136 metres of drilling was achieved.
