Settisg up of Sugar-cum-Paper complex in Punjab

1538. SHRI HARVENDAR .SINGH HANSPAL; Will the Minister.' INDUSTRY be pleased to state:

- (a) whether Government have ceived any recommendations from Government of Punjab for setting up a sugar-cum-paper complex at Dhuri near Sangrur in Punjab by Ballarpur Industries Limited of Calcutta;
- (b) if so, whether any decision has since been taken by Government in this regard; and
- (c) if the answer to part (b) above be in the negative, what -ire the reasons therefor?

THE MINISTER OF INDUSTRY AND STEEL AND MINES (SHRI NA-RAYAN DATT TIWARI): (a) to (c) An application has been received from M/s. Ballarpur Industries Limited for an industrial licence for setting up a bagasse based pulp and paper mill at Dhuri District Sangrdr (Punjab). This project is stated to be a part of their proposals to get up a sugar mill. Distillery for the manufacture of industrial alcohol and a Chemical Unit for the manufacture, of Vinyl Acetate Monomer. The State Government have recommended the application for the setting up of pulp and paper mill. However, the availability of adequate raw material like sugar-cane and bagasse on a sustained/firm basis is to be ascertained before a decisi<» is taken on the application.
