illegally occupied University accommodation. The complaint was brought to the notice of University. The University has clarified that, according to University rules relating to allotment, an employee while proceeding on leave may accommodate, in the residence allotted to him, any other employee eligible to share University accommodation, as a care-taker, for the specified period. In accordance with provisions, a faculty member, who was also Chief Proctor, and was required to stay on the campus by virtue of his proctorial duties, was permitted temporarily to occupy the house allotted to another faculty member who proceeded on study leave. He has since been allotted regular accommodation.

Fuel for Tarapur, Atomic Power Plant

1599. SHRI V. GOPALSAMY: Will the Minister of EXTERNAL AF-FAIRS be pleased to state:

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO); (a) and (b) Officials India and the United States have so far held three rounds of discussions in connection with the refusal by the United States to supply nuclear fuel for the Tarapur Atomic Power Station. After the third round of talks, the Indian delegation submitted a re- . port to the Government which is presently under study. The Government has also initiated studies from the legal and technical angles regarding the Tarapur problem. As soon as a decision on the matter is taken the House would be informed. At the moment, however, no decision has been taken to hold further discussions with the United States on this issue.
