

**Marketing of formulation by
M/s. Glaxo**

1728. DR. JOSEPH LEON D'SOUZA: Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

(a) the names of the formulations being marketed by M/s. Glaxo without any industrial licence and without price approval, their production during the last three years of each formulation, year-wise;

(b) how M/s. Glaxo have justified their manufacture and what is Government's reaction thereto; and

(c) what steps have been taken by Government to take act on against M/s. Glaxo for such offences?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI DALBIR

SINGH): (a) The position with regard to the 12 items *prima-facie* found to be in production without valid industrial approvals and 25 formulations claimed under the Registration Certificates, has been indicated in reply to part (b) of Rajya Sabha Unstarred Question No. 109 answered on 23-11-1931. The production of these items, as furnished by the Company, during the last three years is given in the attached statement. As regards items, if any, which are being marketed without price approvals the position is being checked up and the requisite information will be laid on the Table of the House.

(b) Explanations given by the company in respect of the 12 formulations have been examined and further information called for, which is awaited.

(c) The question of taking action would arise only after the violations are established conclusively.
