THE MINISTER OF LAW, JUS-TICE AND COMPANY AFFAIRS (SHRi JAGAN NATH KAU-SHAL): (a) The Election Commission has recommended that articles 82 and 170 (3) of the Constitution may be amended so that, while the total number of seats to various States in the House of the People and to the various State Legislative Assemblies may remain unaltered, the original position of fresh delimitation of Parliamentary and Assembly constituencies in each State and Union territory after every decennial Census is restored.

(b) The matter is at a very advanced stage of consideration.
