Concession in fares to tourists to Andaman and Nicobar Islands

1786. SHRI **PYARELAL** KHAN-DELWAL: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state whether with a view to attract more tourists to Andaman and Nicobar Islands Government is considering a scheme to give cession in air fares or provide facility of air travel on subsidised rates to the tourists going there as is being done in the case of tourists going to North Eastern regions?

THE MINISTER \mathbf{or} TOURISM AND CIVIL AVIATION (SHRI A. P. SHARMA): On the Calcutta-Port Blair sector, Indian Airlines has given a discount of Rs. 100 for one way as well as return journeys per passenger travelling in a family with a minimum size of 2 passengers. Apart from this, Indian Airlines offers a discount of 30 per cent on fares for domestic groups with a minimum size of 8 passengers, travelling as a part of package tour on the domestic sectors. This facility is available on the Calcutta-Port Blair-Calcutta also.

Indian Airlines fares on the North-Eastern sector are approximately 17 per cent less than rest of India, However, no other special concession is given to tourists travelling to North-Eastern Sector, which is not available in the rest of the country.
