Defence forces personnel missing since the 1971 war with Pakistan

1764. SHRI JAGDISH PRASAD MATHUR: SHRI LAKHAN SINGH:

Will the Minister of DEFENCE be pleased to state:

(a) whether it is a fact that relatives of some of the personnel of the India's defence forces who have not yet been located since the 1971 war with Pakistan, have been aproaching the Government to establish death or otherwise of their relatives; and

(b) if so, what steps have been taken by Goventiment to satisfy the relatives about the death of the defence personnel as is required under the Geneva Convention

THE DEPUTY MINISTER IN THE MINISTRY OF DEFENCE (SHRI K. P. SINGH DEO): (a) Yes, Sir.

(b) Reports appearing off and on in the Press as well as some evidence produced by the relatives ٥f these personnel indicate that some of the Defence personnel, who are missing since the 1971 conflict, may still be detained in Pakistani jails. But in a statement issued by the Pakistan Embassy in New Delhi on Jahuary 23, 1982, they have denied the existence of such personnel in Pakistan. The Government of India repeatedly took up this issue with the Government of Pakistan.

It was once again taken up during the recent visit of the Pakistan Foreign Minister, Mr. Agha Shahi to New Delhi from January 29 to February 1, 1982. The Pakistan Government reiterated its position that there were no such defence personnel in Pakistan. However, on India's insistence, the Pakistan Delegation agreed to make fresh efferts to locate such personnel.
