Indo-Bhutan Rail link

(b) A Memorandum of Understanding has been signed on 25th January, 2005 between the Royal Government of Bhutan and Government of India Under which Government of India shall carry out the feasibility studies for establishing broad gauge rail links between bordering towns of India and Bhutan at five locations. Surveys for the new lines have been taken up.

Basic facilities at dungri Railway Station
