(e) whether the above recommendations have been accepted by Government?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) Length: 3495 Metres.

Estimated Cost: (Railway's portion only) Rs. 43 crores for Main Bridge approximately. Rs. 13 crores for Guide bund.

Total: Rs. 56 crores

- (b) Yes.
- (c) The length of the bridge had to be increased taking into account the erosion on the South bank of the river. The revised length of the bridge is given in reply to part (a). The revised length of the guide bund is 1470 Metres.
- (d) No changes in the bridge or guide bund were recommended by the Tripathy Committee. The Committee's terms of reference did not cover measures for protecting Nowgong District from Flood. The Committee recommended provision of spurs on the south bank as an experimental measure to chanalise the flow and to induce siltation.
- (e) The recommendation made by the Committee a_s explained in reply to part (d) was accepted.

- (c) No firm target was indicated at that stage because a gigantic project like a bridge on mighty Brahmaputra require a great deal of time in the completion of Preliminaries such as site|soil investigations, design, seismic and structural dynamic analysis, pre-qualification of tenders etc.
- (d) Rs. 24.70 crores as intimated by North Eastern Council based on 1978 price level.
- (e) Sinking of four wells on the North Bank is in progress. Collection of boulders for the guide bund work is in progress. Construction of Office building and staff quarters have been completed. Actual work on the guide bund and approaches will be taken up later on.

(f) Yes.

- (a) whether it is a fact that two persons were killed and three injured when the Bombay bound Jayanti Janata Express from Trivandrum ran into a crowd of people at Wadakancheri Railway Station recently;
 - (b) if so, the details thereof;
- (c) whether any enquiry has been conducted in this regard; and
 - (d) if so, the outcome thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) and (b) Yes. On 2-3-1982 while No 82 Up Trivandrum Central Bombay Janata Express was on run between Wadakancheri and

Mullurcarai stations 5 persons, presumably trespassers on their way to a festival at local Bhagwathi Temple were knocked down by the train, resulting in the death of 2 and injuries to 3.

(c) and (d) The Police have registered a case and the result of their investigation is awaited.

Coastal Farmers Adopting Prawns Cultivation

THE MINISTER OF STATE IN THE MINISTRIES OF AGRICULTURE AND RURAL DEVELOPMENT (SHRI R. V. SWAMINATHAN). (a) Yes, Sir.

- (b) These are:—
- (i) Coastal farmers are increasingly switching over from agriculture to lucrative prawn culture, because there is no expenditure involved on labour and fertiliser.
- (ii) In the Karwar Kharlands, the farmers are no longer interested in it desalinating their soil but, on the other hand they cut the bundhs and let the sea water in for rearing prawns.
 - (iii) The thrust during the past 3 decades had been towards extending grain crops, regardless of soil suitability.
