SHRI PRASENJIT BARMAN: Mr. Chairman, Sir, the Geological Survey of India is a prestigious institute of the country and the people of West Bengal are emotionally associated with it since its inception in 1851. Sometimes disturbing reports appear in the press that there is likelihood of the headquarters of the GSI being i transferred from Calcutta. Now I am happy to learn that there is no such decision, but still there are some matters which cause our worry. I want to know from the hon. Minister whether the GSI Review Committee. which was a departmental committee, had recommended that certain organisations such as AMSE, i.e. Airborn Mineral Survey and Exploration Division of Integrated Survey, Field Technique Research Unit and Geochronology should be merged into one institute instead of having their separate existence. I want to know what has been done in respect of this recommendation. Moreover, in Calcutta, this GSI has got one very precious library. That library has been suffering from want of accommodation. About the accommodation problem, what has the Govern-And there is one ment done? proposal also to build up one laboratory at Kyd Street, Calcutta. What has been done about it? I want to know about all these matters.

SHRIMATI RAM DULARI SINHA:

Sir, about the first part of the supplementary of the hon. Member, I would like to say that the recommendations of the GSI Review Committee are under processing; and for the second, according to the increased developing needs of the organisation, the Government will increase all the facilities concerned, as suggested by the hon. Member. (Interruptions)

MR. CHAIRMAN: Just a minute. It is not such an important question.

MR. CHAIRMAN: But it is not being transferred. The answer is 'No'.

SHRI R. MOHANARANGAM: The question is whether there is any proposal under Government's consideration to shift the headquarters...

MR. CHAIRMAN: It is not being shifted. Why are you worried about it?

SHRI R. MOHANARANGAM: Sir, the proposal is there.

MR. CHAIRMAN: It is not.

SHRI R. MOHANARANGAM: Then I withdraw my question. Sir.

SHRI DIPEN GHOSH: Will the Minister be pleased to state whether it is a fact that the Government of West Bengal offered adequate land with all infrastructure facilities in the Mijia-Saltora area on the south of Damodar, the area known as natural field museum of varied geological formation, for setting up of the Geological Survey of India Training Institute, but that the Central Government set up the said Training Institute in Raipur of Madhya Pradeah on the plea of it being the most suitable place for the purpose? But now again the same Institute is being shifted from Raipur to Hyderagad under consideration of the latter's comparative merit for the location of such an institute.

MR. CHAIRMAN: What is the question?

SHRI DIPEN GHOSH: The question is...

MR. CHAIRMAN: There is no question.

SHRI DIPEN GHOSH: This is my question. I place it specifically...

MR. CHAIRMAN: I wish you would do.

SHRI DIPEN GHOSH: ...whether is a fact that though the Government of West Bengal offered adequate land.

MR. CHAIRMAN: That is not being used?

SHRI DIPEN GHOSH: At that time it was not used. The proposal was not considered, and the Institute was set up in Raipur in Madhya Pradesh on the ground that that place was most suitable, and now it is being shifted to Hyderabad on the same ground that Hyderabad is comparatively more suitable than Raipur.

SHRIMATI RAM DULARI SINHA: Sir, various sites were considered, and finally the best site was located. It was found that the best site would be Hyderabad. So, it was done.
