

Brahmaputra as a National Waterway

2136. SHEI ROBIN KAKATI: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

(a) whether there is any proposal under Government's consideration to declare the river Brahmaputra as a National Waterway; and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI SITARAM KESRI): (a) and (b) River Brahmaputra is one of the rivers identified for being considered for declaration as a National Waterway. For this purpose hydrographic surveys and techno-economic feasibility studies of the Dhubri-Sadia stretch of the river Brahmaputra are proposed to be carried out.

(d) if not, what are the reasons thereof?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI VEERENDRA PATIL): (a) (i) Major Port-Cochin

(ii) *Intermediate Ports;*

- (1) Calicut/Beypore
- (2) Alleppey
- (3) Neendakara
- (4) Kovalam/Vizhingam

(ii) *Minor Ports:*

- (1) Kasargod
- (2) Azhikkhal

- (9) Trivandrum

(b) The entry into the port is limited to vessels with a draught of 1.25 m at low water owing to the existence of a bar at the mouth of the river and hence it cannot be considered a natural port.

(c) The Central Government has no proposal to develop Ponnani Port.

(d) As per the decision of the National Development Council, development of minor ports is now the responsibility of the respective State Governments, funds for such developments are provided in the respective Plans.
