(b) and (c) There are, reports of isolated incidents of ragging in some institutions in the country. The Government had advised all State Governments and Heads of Central institutions in July 1975/June 1978 that ragging should be prohibited and those indulging in it should be promptly punished.

## Explosion of Atom bomb by Pakistan

(b) Government are following the developments on a continuing basis. Government of India remains committed to use nuclear energy for peaceful purposes but it is also determined to take all necessary steps to safeguard India's security interest.
