#### News Reports regarding Plastic Blood Packs found in Garbage

### \*368. SHRI GURUDEV GUPTA: SHRI HARVENDAR SINGH HANSPAL:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether Government's attention has been drawn to the news item which appeared in the Hindustan Times of 22nd February, 1982 under the caption "Donors' blood on garbage heap";
- (b) if so, what are details in this regard;
- (c) what action Government have taken/propose to take against the persons responsible for this act of negligence in preserving human blood donated by the public;
- (d) what is the quantity of blood which has gone wasted/destroyed because of the time bar or due to improper storage; and
- (e) what steps Government propose to take to prevent such wastage?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARANAND): (a) Yes, Sir.

- (b) and (c) The Indian Red Cross Society (I.R.C.S.) has reported that a few used empty blood packs and one pack with outdated red cells, unfit for use, were found in the garbage. This does not indicate any negligence in preserving donated human blood.
- (d) the I.R.C.S. has intimated that during 1981 only 11 units had to the discarded out of a total collection of 19,620 units as the blood was not fit for transfusion. In addition, plasma was extracted from 47 units where there were no takers for 21 days from the date of collection, for use in cases of burns. etc.
  - (e) Does not arise.

## Induction of IFS(B) Officers into IFS(A),

- (a) whether it is a fact that a decision was taken last year to increase the quota for induction of IFS(B) officers into IFS(A):
- (b) if so, what are the reasons for the delay, in implementing this decision; and
- (c) what steps Government propose to take to ensure that pending implementation of this decision the additional vacancies which would be available to IFS(B) officers are not utilised for promotion of IFS(A) officers?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIM-HA RAO): (a) Yes, Sir.

- (b) Necessary action is being taken, in consultation with the concerned departments, for the implementation of the decision.
- (c) The decision with regard to the proposed amendment will be implemented immediately after the issue of the necessary gazette notification. It is premature to consider the question of vacancies at this stage.

News Item regarding Death of Persons due to Sterilization

- (a) whether Government's attention has been drawn to the news item which appeared in the Indian Express of 1st March, 1982, Delhi edition, under the caption "Sterilisation drive leaves 2 dead"; and
- (b) if so, what are the details in this regard?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI B. SHANKARANAND): (a) Yes, Sir.

(b) It is learnt from the State Government of Orissa that two of the women who underwent sterilisation operation voluntarily in camps on 9th and 12th February, 1982 died later on fourteenth and sixteenth February due to suspected internal haemorrhage and diarrhoea accompanied by renalrailure respectively in spite of adequate rare.
