Diphenoxylate Bulk Drug

2239. SHRI K. V. R. S. BALA SUBBA RAO: Will the Minister of PETROLEUM, CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether it is a fact that the bulk drug Diphenoxylate was classified as involving high technology by the high level committee in their report of 1979; and
- (b) if so, how this bulk drug was later classified as not involving high technology by Government?

THE MINISTER OF STATE IN THE OF PETROLEUM, MINISTRY CHEMICALS AND FERTILIZERS (SHRI DALBIR SINGH): (a) the process of manufacture of Diphenoxylate was not considered by the High Level Committee for assessment of the level of technology as no foreign company was manufacturing it, and there was no pending application for this drug from a foreign company at that time,

(b) Based on the information furnished by a foreign company in its application for an industrial licence submitted in 1980 and applying the criteria for High Technology laid down by the High Level Committee, it was classified as not involving high technology.

- (d) if so, what are the details thereof and what steps are proposed to be taken by Government in this regard?

Pfizer to selling of twelve reformulated Schedule V mul-vitamin formulations at their own prices which have not so far been approved by the Government have come to the notice of the Government.
