THE MINISTER OF DEFENCE (SHRI R, VENKATARAMAN): (a) to (d) Negotiations with the French Companieg for the supply of Mirage-2000 aircraft are still in progress.

- THE MINISTER OF FINANCE (SHRI PRANAB KUMAR MUKHERJEE); (a) to (e) There has been a significant improvement in the economic situation during 1981-82. The detailed review of the economic policies will be presented in the Eco-, nomic Survey 1981-82 and the Budget for 1982-83.
- (f) There i_s a proposal to deposit only the arrears of Dearness Allowance into the Provident Fund accounts of the employees. There is no proposal under consideration regarding wage freeze

Supply of French Mirage Aircraft to India

- 212. SHRI K. L. N. PRASAD; Will the Minister of DEFENCE be pleased to refer *0 the answer to Starred Question 74 given in the Rajya Sabha on the 26th November, 1981 and state:
- (a) whether jndia and France have since finally signed on agreement for the supply of French Mirage aircraft to India;
- (b) if go, what are the main features of the agreement;
- (c) whether the agreement has given a greater morale boosting to the $India_n$ Air Force;
- (d) to what extent the Indian Air Force is likely to meet the Pakistan's threat after the latter acquires the F-1S planes from U.S.A.; and

(e) whether Pakistan has already received all the arms and ammunition from the U.S.As for which an agreement was signed earlier?

THE MINISTER OF DEFENCE (SHRI R. VENATARAMAN) (a) No, Sir.

- (b) and (c) In view Oi (a) above, do not arise.
- (d) Government are taking appropriate steps to meet the situation effectively. It is not in the interest of national security to disclose the details.
- (e) Government have seen reports that Pakistan has concluded agreements with the U.S.A. for the supply of arms and ammunition and that supplies would commence hereafter.

Education in IDA Assistance

- SHRI NARSINGH NARAIN 213. PANDEY; Will the Minister of FINANCE be pleased to state:
- (a) whether it is a fact that Mr. A. W. Clausen, World Bank President, is exercising pressures for reduction in the IDA assistance in the current fiscal year; if so what are the details thereof:
- (b) whether the cut in concessional assistance is likely to create problems in various sectors of development and Economy of the country; if so, what are the sector-wise proposals to be affected if any; and
- (c) whether the World Bank has forwarded any proposal for consideration of the Government for reduction in Air proposals; if so, what are the details thereof?

THE MINISTER OF FINANCE (SHRI PRANAB KUMAR MUKHERJEE): (a) and (c) No, Sir. However, there is a reduction in the overall funds available to IDA during the Bank's fiscal year 1982 (July 1981- June 1982) due to the fact that the United States and other donor countries have not paid in their contributions to the second instalment in amounts agreed to at the time of the

Sixth Reagreement on the plenishment. Although there ia a likelihood that this will result in reduction in the funds available to India in FY 982, we have not been officially notified of the exact amount. We are, however, making every possible efforts to ensure that the maximum possible funds are made available to India.

(b) While a reduction in concessional assistance would inevitably affect our balance of payments position, it is not possible at this stage to quantify these effects.
