## **Modernisation of police force**

†217. SHRI JAI PARKASH AGGARWAL: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the details of the State Governments from whom proposals for the modernisation of police force have been received by the Central Government till date during the last three years;
- (b) the amount Central Government have allotted to State Governments for the modernization of police force till date during the said period; and
- (c) whether Central Government have made any assessment or purpose to make any assessment with regard to the utilization of the said amount allocated to State Governments?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SHRIPRAKASH JAISWAL): (a) and (b) Under the Scheme for modernization of state police forces, proposals were received from all the State Governments during the last three years *i.e.* 2003-04 to 2005-06. The total approved plan during the period 2003-04 to 2005-06 was Rs. 3771.36 crore, against which Central funds to the tune of Rs. 2690.27 crore were released. A Statement showing the State-wise release and utilization of funds for the period 2001-02 to 2005-06 is attached (See below).

(c) The matter regarding optimum utilization of funds under the scheme is reviewed in the Ministry from time to time with the representatives of the concerned States. Central teams have been visiting the various states to monitor implementation of this Scheme. Assessment made by the Central teams is shared with the concerned State Governments. Impact assessment of the scheme is also being carried out by Bureau of Police Research and Development. (BPR&D).
