- (c) whether the experts from Archaeological Department have been deputed to look into the matter; and
- (d) if not, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRIES OF RAILWAYS, EDU-CATION AND SOCIAL WELFARE, AND DEPARTMENT OF PARLIA-MENTARY AFFAIRS (SHRI LIKARJUN): (a) Development cracks on the Khajuraho temples are attributed to aging, continuous weathering and corrosion of iron dowels used in the original dry masonry construction; the sound vibrations aeroplanes at Khajuraho are noi of such magnitude as to cause damages to structures.

(b) to (d) Necessary structural repairs have taken up to protect the historical monuments, under the supervision of the experts of the Archaeological Survey of India.

- THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) Yes, Sir. The services of M/s. Baron Canning and Company, New York, have been engaged on a trial basis. They had in the past been engaged by the South African Government. They represent Taiwan in the economic field.
- (b) The Government have seen Press allegations to this effect but are not in a position to confirm this.
- (c) The Government have strengthened the press and publicity efforts of Indian Missions in the USA. It was however felt that these needed to be supplemented in certain areas in a manner which could only be done by a local firm. We are satisfied that the services rendered so far have justified this decision.
