STATEMENT BY MINISTER

Correcing the reply given in the Rajya Sabha on the 8th September, 1981, to Unstarred Question 1980 regarding the income and wealth of the wife and children of Shri D. Seth

MR. CHAIRMAN: Now, statement by Minister correcting answer to a question.
