CALLING ATTENTION TO A MATTER OF URGENT PUBLIC **IMPORTANCE**

Reported decision of the Government to issue fresh special bearer bonds both in India and abroad from 1st December, 1981, and its effect bn the country's economy

SHRI G. C. BHATTACHARYA (Uttar Pradesh): Sir, I beg to call the attention of the Minister of Finance to the reported decision of the Government to issue fresh special bearer bonds both in India and abroad from 1st Decemb∈r, 1981 and its effect on the country's economy.

MINISTER \mathbf{OF} FINANCE THE (SHRI R. VENKATARAMAN): Sir, the Special Bearer Bonds (Immunities and Exemptions) Ordinance, 1981 was promulgated by the President on 12th January, 1981 and Special Bearer Bonds were placed on sale from 2nd February, 1981 in India and from 9th February, 1981 abroad. The Ordinance was later replaced by the Bearer Bonds (Immunities and Exemptions) Act, 1981, after it was duly passed by both the Houses and received the assent of the President on the 27th March, 1981. However, petitions were filed in the Supreme Court challenging the Constitutional validity of the Ordinance and the Act, The Government therefore, decided to suspend the sales after 30th April, 1981.

As the House is aware, Supreme Court up-held the Constitutional validity of the said Act on 2nd September, 1981 The Government have, therefore, decided to place the Bonds again on sale with effect from 1st December. 1981 for a period of one month.

The current year's Budget assumes a receipt of Rs 800 crores from the sale of these Bonds against which only Rs. 296.91 crores were collected in April, 1981. The Government hope to realise the Budget estimate on this account; any further realisation will go to reduce the deficit and augment the resources for the Plan.
