#### Reserve Bank of India circular regarding suspension of bank loans in N.E. Region.

917. SHRI ROBIN KAKATI: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that a circular was issued to all North Eastern Region nationalised and other commercial banks not to issue any loan at least for coming three months till further direction received from the Reserve Bank; and

(b) if so, what are the reasons therefor?

THE MINISTER OF FINANCE (SHRI R. VENKATARAMAN): (a) and (b) No such instructions have been issued either from the Government or from the Reserve Bank. On the other hand banks operating in the region have been advised to strengthen their existing set up in the region and undertake developmental banking in addition to their commercial functions, for rapid economic development of the region.

#### Installation of a Mini Steel Plant in Private Sector in Assam.
